Micha Anderson- (26:10) born and raised in Krebs my name is Micha Anderson. My mother was born and raised here. my grandfather lived here for years. I lived here my whole live. I look around at

the crowd a lot of people I haven't seen in years and years. I have a lot at stake in Krebs. I believe. What I believe and what I want would be a connection of community back to city government and the citizens. For years and years and years growing up that was a big connection. This town everybody knew everybody. Everybody was connected City leadership knew everybody in town, everybody in town knew everybody in city leadership. The more I talk to people now days it's not the case. Most people don't even know who their city council people are. Most people don't know who the mayor is. Most people don't know anybody. My goal would be to work towards that. In my day-to-day job, I'm a communicator that's what I do. I talk with people from all over the world. I manage; I'm from McAlester ammunition plant I've been out there 20 years. I manage all the storage space out there. Just got back from a trip; Washington State Thursday. That's what I do so I'm pretty good at communicating, I believe in networking I believe in doing whatever it takes to make it work. I think Krebs can be a great, great town. I really do. I think that is going to require somebody that's open minded and passionate. I am both of those things. I am approachable. I'm in town all the time. People see me, I'm not hiding at home, I'm out and about everywhere. I'd be willing to talk anything to anybody anytime. Any questions or concerns with that I'm always around.

Zella Kincaid- (29:10) Good evening neighbors. Of course, y'all know my name is Zella Kincaid and I am running for Krebs Mayor. A little about me; I am an active community advocate for 20 years and still going. I am a motorcycle enthusiast you have probably seen me riding my motorcycle around for 23 years now. I am an active martial artist dedicated 28 years now. I was inducted into the martial arts hall of fame recently. I'm an avid runner; you've probably seen me running around town. I have a college degree in health and nutrition. I have been a citizen of Krebs for 35 years. My recent community engagement in Krebs was helping get the acknowledgement- we had some unsafe bridges at the track. I sent some emails and we ended up getting those bridges replaced. I then noticed there were some side-by-sides driving around going across that bridge so I brought that to their attention. Cindy ordered some signs; we got those signs put up that say no motorized vehicles on the track. I truly believe in the power of the community of Krebs and not the power alone of just one single office. I'm not here to make any promises that are hard to keep but to serve and work for your well-being. As we know our city operates under a weak mayor system and that means the real progress does not come from one person making decisions and demands, it comes from all of us. The mayor and the city council working together that way we create a team. There are many things we can work together to do in our community like our local education system, our small businesses the residents of Krebs, fire department, police department and recreation. The most important thing is good communication. My role as your mayor would be to encourage discussion and not dictate. I would work with Krebs school board, parents, teachers finding resources and funds to ensure our children obtain the opportunities they need for success. Now let's talk about our small business. Supporting our small business here in Krebs is very crucial for our economy. Since we have a weak mayor system, I alone cannot demand new construction in Krebs but I can ensure that all of the business and business owners have the available resources

My strategy is based on visionary leadership, communication, community engagement, transparency, participation, and compassion. I will serve in my position as your mayor to communicate properly, lead discussion, build partnerships and direct people to resources suitable for their needs. It is my nature and my personality to help others and am a very transparent person. I will do what is right even when no one sees what I am doing. As a whole community we are stronger together when we work together by listening and then by collaborating. With team work we can make great changes and achieve better outcomes. Evett Short-(32:42) My name is Evett Short, on the ballot it will be Mary Evett Short. Two years ago, I moved into the city limits with the hopes of running for Ward 1 but something else came up so I decided to go ahead and put my hat in for mayor. With my education I have a masters degree in human resources administration a minor in business and pre-law. I have 30 years work experience within the community and the city of Krebs, well not really Krebs but McAlester. I worked for the hospital, McAlester Regional, I worked for DHS, I worked for Stipe law firm I worked at web-co that was my last position when they sold. I also have 18 years of experience with the Boy Scouts of America as well as American Red Cross. I may have taught your children swimming lessons. My current location is over here on Krebs Lake Road but my whole family has lived on Krebs Lake Road for the last 38 years. They are all two miles north. I am on a cute little acreage. If you don't know it, its Virginia McAlester's old property. I bought her place. I have some goats there I have set up a farm stand but right now we just sell eggs but there will be all kind of goodies out there so y'all just come by and visit this summer. I want to promote Krebs. I want to keep the Italian Heritage alive. I want to see it to continue to move forward. We're kind of dying here a little bit, our main street is dying, our buildings need repair. Things need to happen we need to kick it back in gear again. I would like to see the parks be improved. We have a wonderful park, a big park but there are also some smaller parks in the community. They still need a little bit of attention. It would be nice to bring the neighbor hoods even closer together. I love the sidewalk project that happened here. Yeah, it's amazing to see kids walk to and from school. I love the idea of the homes that have been abandoned that are being torn down and cleaned up which is making our community look better. Its just really means so much to see that. Keep that heritage alive, keep things moving forward for progress. What I would also like to see is our community work together. I've been big into farming; farmers market and all that good stuff. We have a cute little farmer market down at the end of town. Way on the end of town. I'd like to see it move in a little bit closer. We have a downtown. We do, and it's right here this street just right her next to the court house. I think it would be amazing to have a food truck night. I think it would be great to have a farmers' market. Have the community come together as a whole. My name is Evett, I am running for interim mayor. Just think of me. Thank you.

Caylin Crone- (36:04) Good evening council and city of Krebs. My name is Caylin Crone; I am running for the interim mayor for the city of Krebs. I am also a lifelong resident of Krebs. I left only for college and the first two years of being a teacher before coming back home and teaching at Hartshorne for couple of years. This community has raised me, and I always believe that when you love where you are from you have a responsibility to help protect it, and improve it. For the past four years I have been deeply involved in city issues not as an employer or elected official but as a concerned citizen who believed that our city could and should do better. During that time, I discovered some city actions where not being conducted in accordance with state law or our own city ordinances. I am very familiar with municipal law and took time to research additional laws and bring them forward and worked with city leadership including the city attorney at that time, to help correct those issues. Because of that improper practices were stopped and our planning & zoning board was reestablished so zoning could once again be handled legally and correctly. I have also found problems within city budget, spending and misuse of funds. I didn't stay quiet about it. I spoke up, asked questions and demanded accountability because that's what tax payers deserve. Also, citizens should not have to come to meetings and publicly speak to be heard. Our city needs structural improvements, responsible financial management, and leadership that is focused on long term solutions not short-term convenience. If elected to fill the remainder of this term I am ready to get to work immediately because I already know the issues, and where improvements are needed. I am the only candidate that has been actively and consistently involved in city operations and meetings over the last four years without holding a city position, and I believe that matters. It shows that I am willing to stand up for this community whether I have a title or not. I love this town, I care about the people who live here and I believe Krebs deserves leadership that is transparent, lawful and truly focused on serving its citizens.
