L. CONSIDER AND ACT TO APPROVE TO JOIN THE MCALESTER DEFENSE SUPPORT ASSOCIATION. JESSICA GREGG PRESENTATION AND DISCUSSION ON OUR OPTIONS TO BE A PART OF THE MDSA. Jessica Gregg addresses the council. MDSA is a 501c6 organization that advocates for the defense industry. McAlester Ammo plant is big part of that industry. Other contractors in area as well include Choctaw Nation. MDSA works to build this industry through Oklahoma and Washington delegations. Organize a stampede once a year where they meet with legislation to express the needs and concerns that the base might have. Direct hire is an initiative that was passed on their request. This gives them the authority to hire without going through USA jobs, which cuts hiring time from 160 days to 63 days. They have grown over 300 employees since it was passed. They want to have an accurate representation of who supports the base. They know that it's not just McAlester, there are people who live in Krebs and work at the base and want to invite Krebs to be part of their organization. Mayor Watkins asks Ed if he was familiar with this. Ed says somewhat he did work at base. Ms. Gregg says has been around since 2009. Senator Inhoff came to them and said base was only place that didn't have organization in Oklahoma that support industry. Ed states if it wasn't for their economic development in this area things would be drastically different around here and thinks would be a good idea to join their organization. Ms. Gregg says there will be over 400-million-dollar benefit to this area. Mayor Watkins went over the membership options. Asks for any discussion. Pat Layden asks if there are any other cities involved in this. She states McAlester supports ½ of their budget, and Pittsburg county is \$5000 member. She has reached out to Atoka, Stigler, Eufaula and Holdenville. She is to present to those areas they have larger percentage of employees living in their areas. People are traveling from 27 counties to work at the base. Pat asks if any one raised issue on legality of the cities being involved. She states they have open meetings and McAlester is a member. Connie asks Mike what fund this would come out of and Mike replied the general fund. He says he would like to check on this before we agree to anything. Pat states he would like to check with OML as well before we agree to anything. Pat states we can table it or pass with subject to legal approval. Mayor Watkins asks for a motion to pass the Silver membership \$500 a year, pending legal approval. Mayor Watkins asks for a motion. Connie Poole makes motion. Daulfin Bennett seconds motion. Mayor Watkins takes a vote. Daulfin Bennett – yes, Jason Wagnon – yes, Connie Poole – yes. Motion passes.
