- 6. REVIEW CITY OF KREBS FINANCIAL STATEMENT WITH MIKE KERN. Page 3 Statement of Revenues and Expenses. For the month of January 2018 Revenues were \$142,292.23 and the seven months ending were \$1,019,227.77. The sales tax are slightly ahead of the budget. The budget for the whole year was \$1,303,438.00. Page 5 Expenses for the month of January were \$166,697.94. We had expenses in excess of revenues by \$24,405.71. We transferred \$25,000 to the KUA. Expenses for year to date were \$982,215.33 so we have a positive Net Income for the seven months ending of \$37,012.44. I don't see anything else unusual. Any questions or comments?

- 8. BUSINESS NOT PREVIOUSLY CONSIDERED
 - A. CONSIDER AND ACT TO PURCHASE SIX (6) TOUGHBOOK COMPUTERS FOR THE POLICE DEPARTMENT IN THE AMOUNT OF \$25,752.00. THE MONIES ARE AVAILABLE USING THE IT FUND. Police Chief Dennis Cook stated these are to replace the computers in the squad cars. We have 6 that we have online currently. We purchased the ones in the cars now in 2011. Would like to use the funds from the IT Funds for the purchase. There is roughly \$74,000 in the account now. Pat Layden, City Attorney, asked how could you use the old ones? Chief Cook responded they (Turn-key mobile) would only give us \$200 a piece for the old ones. We could erase them and if the water plant needed one or we could use one in court. Animal Control could use one. DPS will have to erase them, this will be at no cost. DPS will have to program the new ones. Mayor Watkins asked for a motion. Connie Poole made the motion. Daulfin Bennett seconded the motion. Mayor Watkins called for a vote. Daulfin Bennett yes, Jason Wagnon yes, Connie Poole yes. Motion passes.
 - B. DISCUSS THE AWARD OF \$20,000 FROM TSET. TSET APPROVED A REVISION OF THE USE OF THE MONIES FROM A SPLASH PAD TO REPAIRING THE WALKING TRACK. Mayor Watkins stated it seems to be more feasible to repair the walking track verses of the splash pad. Any opinions? Daulfin Bennett, Jason Wagnon, and Connie Poole agreed. This isn't to be voted on. This is just to keep you informed.
 - C. CONSIDER AND ACT TO APPROVE THE CONTRACT FOR PITTCO/MCALESTER BOYS AND GIRLS CLUB FOR ONE (1) YEAR. Terry Green with the Boys and Girls Club. Would like to thank you for letting us use your fields. The name is actually the Southeast Oklahoma Baseball since we merged. Last year the fields were in bad shape most of the year and we were depending on volunteers to come in and work/mow. This year we have paid staff to mow the fields once a week. Had a meeting last week with Ed and Connie, Shawn and myself last Thursday. We walked the fields and they let us know what needs to be mowed and cleaned up. We are in agreement to keep everything up to par. Hoping you will let us come back. Mayor Watkins asked for a motion to approve the contract. Daulfin Bennett made the motion. Jason Wagnon seconded the motion. Mayor Watkins called for a vote. Connie Poole yes, Jason Wagnon yes, Daulfin Bennett yes. Motion passes.
