**Richard Cotton**, we need a survey first, right off the bat. We don't even know why they're wanting to vacate it. We kind of know about what it is. But until we see a survey I'm not even going to consider it

**Chairman Moy**, Reason being is that we don't know where it's at on that roadway. Is it two foot on the roadway? Because if we close the roadway then each person gets 20 feet because the roadway's 40. We need to have a survey. I don't know how we can close the road. I don't know what the whole problem is, but I kind of do. I make a recommendation that we table this and request a survey. See where that house is located on the lot?

### Richard Cotton, I'll make a motion we table this until we get a valid survey.

**Chuck Nelms**, basically, I was asking the planning committee if they would consider closing the rest of the alley to go along with this. I didn't know you could close part of an alley, you done all of it or none. But evidently at some point in time they done partials.

Chairman Moy, we didn't either.

**Chuck Nelms** there's some trees in there, some buildings in it. That old barn on my property is in the alley too, which was built in 1890. I mean it ain't like anything you're going to do about it.

**Chairman Moy** ask neighbor Steve Ott if he had any opposition to closing the alley **Steve Ott**, no
