8. REVIEW CITY OF KREBS FINANCIAL STATEMENT WITH MIKE KERN

Out of order* Done between 9.C & D due to accountant running late

Mike Kern, turn to your financial statements on the city and let's start on the page one, the statement of assets, liabilities and fund balances. And the reason I'm doing this is because a little bit later on the agenda,

I'm going to show you the difference between the bookkeeping report plus versus the annual compilation report. So, this lists out all of our assets and then over on page two, that's our liabilities and fund balance. Okay. Then over on page three, this is the income statement just for the seven, our total revenues for the month of July, as you can see, \$209,126. 61. Then we have to go all the way over to page five. We spent \$288,089. 52 cents. So, we spent quite a bit more than we took in, but we can do some analyzing here. First of all, over there on page three, when you go down under the city clerk, you have the general insurance and the health insurance. You can see those are big payments. The health insurance is going to average something like that every month. But the general insurance that's and that's normal. They usually, for some reason we always have to pay that in July, but it's for the whole fiscal year, but we have to pay it out. And then one of the other things on page three were capital expenditures within the police department and this is all within the budget, but we spent \$70,000 there and that's not going to happen every month. So that explains quite a bit of why we spent more than we took in, but I'm certainly open to any questions or comments.

Mayor Walker, should we have we waited then? Since the police so much money on that capital outlet. Should we have waited until we had the money before we got the bought a car or whatever?

Mike Kern, we've got the money. It just doesn't show it here. It's just that we, well it's called a timing difference. We were paying for all this in the first month of the year and that's supposed to be spread out for the whole year. but if you remember from year to year, that usually is what happens. A lot of times we're waiting right at the end of the previous year so that we can get, because some of that stuff they have to order and it takes them a while to get it.

Mayor Walker, I know it's showing her cash general fund. We're down \$31,000 something, so we don't have any money in the bank. In general fund or what?

Mike Kern, there's outstanding checks and there's transfers that will be made during the month during the upcoming month. If you look at that transfer sheet and it's right in front of the, I think it's right in front of the financial statement's orders. That shows you all the transfers. Michael and I have been working on those transfers and Mike was doing a heck of a good job on this stuff. You can see from the ticket fund to the general fund; we transferred last month a total of \$60,000 and that's normal. All the ticket money goes into the court bond account and then we transfer it over as we need it and so there will be some, he's probably already transferred some money in the month of August because like you say, counting our outstanding checks, it shows that we're in a negative cash balance. But sometimes that's normal. Like I say, the first month when we've spent out, when we've paid out that much money, that usually is what happens. Any other questions? That's a good question though.

Dan Heathcock, I haven't been able to see where, when we were told, we were going to get our figures last month for the estate, for what? The state has given us revenue for each business. What? Each business.

Mike Kern, I don't, can't get that. I can't get that.

Dan Heathcock, I misunderstood you. I thought you was going to get the

Mike Kern, no, not for that. No, only the treasurer can get that. For each business. You have to act, talk to the Oklahoma Tax Commission, the sales tax division. But they certainly won't give it to me.

Dan Heathcock, we promised we won't have that last month, and I misunderstood Mike. I thought Mike would get it for us.

Brooke Mason I am coming up here regarding my driveway. I just kind of need to know, I've contacted in between 06/17 to 8/14 Councilman, I came up to the, on 8/14 I came up to the city of Krebs regarding my driveway. Still, nothing's been done no result. My husband actually contacted them on 7/ 29. He called up here and we were told that it was going to be put in a work order. When I came up here on 8/14 team to be asked to put on the agenda, I asked where the work order was, where we were at. I was told by the city clerk that they would get to me when they did. I asked if there was some type of tracking. They kept saying no basically that they pointed out towards maintenance area. I shouldn't have to communicate with them. I just feel like I just need to know when something is put in front of the city council regarding an issue. When is the deadline, when there's going to be tracking, when there's going to be accountability for taxpayers that

actually pay taxes in Krebs. So, my concern is whenever I went to regarding my driveway, I just need to know where we are at on that and when is it going to be fixed.

Mayor Walker, you live right behind that pink building, right? I've been there three or four times and your is solid concrete all the way out to the road.

Brooke Mason, it is I'm aware actually there isn't. It's 13 feet long, 24 inches wide and three inches deep from our that has the driveway has or the road has disappeared or rotted out whatever, rained out, whatever. And back between, actually back between whenever I called several times. So, between 6/24 and seven two, you actually fixed those spots down the road on Northwest Second Street down our street. But you never came to the complaint that I'd had since June. So, I guess that's kind of my concern. So, I have pictures of it, I showed them, I sent text messages to Ms. DeFrange, so I just want to know where the status is on that and how long does it take to get something done after 63 days.

Billy Robinson, as soon as I can get asphalt, I'll put something down.

Brooke Mason, well that's what I was told for 63 days.

Mayor Walker, we got to wait until I give it that,

Brooke Mason but that's my question. I guess where the accountability is, I'm a taxpayer in Krebs and I just want to know when I just need what is the guidelines on that because I was told that's what it was whenever we called on back in 6/17 and then when my husband came and called again on 6/29, we were told the same thing and here we are eight, I mean we're 63 days out and we still can't get access to that. That's why I'm so confused on. Where is the tracking and accountability I guess is my question.

Mayor Walker, have you noticed we've had a lot of tree damage and stuff?

Brooke Mason, Oh I'm well aware.

Mayor Walker, they have been really busy on that.

Brooke Mason, you came down my road between seven two and actually 6/24 and 7/2 and actually fixed the holes down the road. So, I'm just curious on how that didn't get fixed during that time as well. Well, that's my question to the city council is where's the tracking on that? When a problem is reported as taxpayers and in Krebs, where's the tracking or communication that I know it's going to be done or not done? Besides that, when.

Mayor Walker, I don't know. I've not seen it because I've drove three times by that.

Brooke Mason, well, Mr. Coxsey came out, he actually came out thank you very much last night. I called him last night or we talked and he actually came out. I sent him pictures and he verified that too. So, I'm not for sure on, and that's my question again, where's the accountability? Who do I report to who I don't report to?

Sherry DeFrange number one, you're in ward three.

Brooke Mason, well in all respect you're correct on that and he's not in my ward either, but it's just called communication and you could have communicated back with me, it's just like a customer service. I know you actually did drive by on 7/2 and my husband sent you a text message when you drove by because he was outside and said still not fixed and no response.

Sherry DeFrange, I couldn't see anything.

Larry Coxsey, it's not just a big chug hole but where the end of the driveway stops, the asphalt has sunk down and made just a dip. Kind of like a dip. So now in its long, like she said, if she's coming and turning off there and the asphalt's down or somebody's driving by and runs over the edge of her driveway, it's a big truck trash truck, it's going to break it off.

Brooke Mason which is going to break our driveway.

Mayor Walker, well like I said, bill, we don't know when we're going to get any asphalt.

Billy Robinson, I'm at the mercy of the county.

Mayor Walker, we just got to keep checking when they say they got some asphalt, we'll get some. Otherwise, they won't let us have any.

Brooke Mason, Well that's kind of my concern as a taxpayer in Crips. I think that's why I came up here is because it's continued. This is the runaround we're getting and I just want to know what type of tracking or documentation or communication or lack driving by and you not see it but y'all two both drive by, y'all don't see it. It's been the same and Mr. Coxey drives by, gets out whatever and sees it. So that's where I just want some accountability and that's kind of what I'm wondering because I am a taxpayer and I expect when, and not just me but everybody else when there's questions or concerns, we want it done just like you would want something done as being a taxpayer as well. And I think that's what it is, is I'm where I'm at is just an accountability on where's the communication going to be.

Larry Coxsey, Can I ask y'all a question because I'm not aware y'all have a list when people call up here and have a complaint that you got a big chug hole or something, do y'all have a list you put it on so it's in an order to work order. Well at least it's in an order where this person has called in and kind of put them in order on how we need to go about fixing it. I just know Do we have a list yet? Can we create one.

Jayme Busby, I usually get most of those phone calls and so I do make a work order and it goes out to the crew. They keep their list and their priorities out there. I don't see it once it goes out, once it goes out there.

Brooke Mason, so that's my question is where's that? I mean he said he didn't have it so I'm just curious on where's that and she did tell me that she says that. That's why I'm so confused. We're getting two different answers.

Mayor Walker, Alright, we'll start getting a list then.

Larry Coxsey, can we start creating a list and then get her, like I said, as soon as you, soon as I can bring asphalt since it's been 63 days and I'm just, my whole thing is I just want communication. I mean that's how it is when anytime you call and want something done, I just want communication back and forth to say, hey by the way, pick this up. We didn't have a chance to do that. I think that's all it has. I think there's just a lot of lack of communication, accountability and that's kind of where I just would like to see some type of just some feedback back of what's going on versus me having to spend time and documentation and I have it all down with my cell phone as well. That's kind of where I'm at. And just to get it done.
