#### 5. FINANCIAL REVIEW WITH MIKE KERN

**Mike Kern**, turn to page two. The income statement, modified cash basis for the one in two months ending August 31st. Our total revenues for the two months, \$240,208. Our operating expenses were \$254,738.26. This last month we had a lot of expenditures for Momar. You can see the supplies in the month of August were \$31,422.22. We continued to have that issue. All I can do is report on it.

**Chairman Walker**, summertime it stinks worse, so we got to put more in there. In the wintertime it ain't as bad.

**Mike Kern**, like I was talking about before on the city side, we transferred money over there for the payroll. We transferred \$50,000 over there. So, this year to date we've transferred \$62,440.98 from the KUA over to the city. Those were monies, ARPA monies that were supposed to be used over on the city side. Now when they start talking about mayor, you were talking about they're going to talk about the engineer was going to do some more bidding on some more of the dam work.

**Chairman Walker**, No, not the dam. Over there on Bocci it floods every time it rains over there. That's been flooding for years and years and years. He's got the plan all drawn up, how to fix that problem and he's getting ready to put bids out this week. For that job out there out at the lake out there he's got the first part of it done. They poured the concrete walls.

**Mike Kern**, that was one of the things that I was talking about. If we have extra meetings, that would be one of the things that we'd want to sit and talk about because if we have to finance some, we're going to have to find someplace to finance.

Chairman Walker, so far everything is paid for.

**Mike Kern**, yeah, everything is paid for so far, but we need to know ahead of time so we can make plans if we need to borrow. Especially when we get further down the road and you start working on that water plant, there's going to be all kinds of financial information they're going to want and rightfully so. It's no problem. And then they'll have different programs for how much you could borrow, how much you can get on a grant, how much matching, all that kind of stuff.
