- 3. CONSIDER AND ACT TO ACCEPT THE RESIGNATION OF JACK R. SUTER, POLICE OFFICER EFFECTIVE FEBRUARY 18, 2017. Police Chief Dennis Cook stated Jack applied and was accepted to McAlester Police Department. He starts March 6th, 2017. Mayor Watkins asked for a motion to accept his resignation. Daulfin Bennett made the motion. Jason Wagnon seconded the motion. Mayor Watkins called for a vote. Daulfin Bennett – yes, Jason Wagnon – yes, Connie Poole – yes, Tommy Walker – yes. Motion passes.
- 4. CONSIDER AND ACT TO ACCEPT THE RESIGNATION OF DAKOTA Q. GRANTHAM, POLICE OFFICER EFFECTIVE FEBRUARY 18, 2017. Police Chief Dennis Cook stated same applies to Mr. Grantham. They both applied and was accepted to McAlester Police Department. He starts March 6th, 2017. Mr. Grantham is still under a 3 year commitment to the City of Krebs. He will pay back \$4,500 for the expense of getting him started. He was only 2 years into his 3 year commitment so he is a breach of contract. We have come to an agreement that he would pay us back. Mayor Watkins asked for a motion to accept his resignation. Connie Poole made the motion. Jason Wagnon seconded the motion. Mayor Watkins called for a vote. - 5. CONSIDER AND ACT TO HIRE COURTNEY D. SMITH AS A POLICE OFFICER EFFECTIVE MARCH 6, 2017. Police Chief Dennis Cook stated that during this process we tested together with McAlester. There were 27 applicants tested and 15 passed then we chose 6 to be interviewed. Miss Smith works for McAlester as a dispatcher, she's CLEET certified and has a criminal justice degree with a 4.2 gpa, and is a kick-boxer against men. She will be a good asset to Krebs because we average 11 to 12 sexual assaults per year. She could be an asset working with the females and children. She ranked #2 during our interviews with the interview board. She will be on probation for up to 1 year and will be evaluated after 90 days. She will sign a contract for a 3 years commitment. If contract is breached, she will have to repay the city \$6,500. Mayor Watkins called for a motion. Connie Poole made the motion. Daulfin Bennett seconded the motion. I have cancelled all leave for 90 days. For the next 9 months, only on a case by case basis will they be allowed to take off.
