8. REVIEW CITY OF KREBS FINANCIAL STATEMENT WITH MIKE KERN.

Mike Kerns states the month of March a revenue of \$162,679.81. Total expenses for the month of March was \$208,532.42. On page 4 the month of March the expenses from Capital Outlay for the Police Department was \$19,915.43. Also, on page 4 the expenses from Capital Outlay in the General Government which was for computers in the amount of \$35,541.90. Capital Outlay in the Park was \$23,390.00. Mike states that we show more expenses than income by \$45,852.61, but year to date, Mike states we are still positive by \$78,097.92. Mayor Watkins asks if the Council has any questions.

9. BUSINESS PREVIOUSLY CONSIDERED.

A. CONSIDER AND ACT TO APPROVE THE ESTIMATE OF \$4,901.00, FROM J.D. THOMAS CONSTRUCTION FOR CONCRETE SIDEWALK THAT WILL RUN FROM WALKING TRACK TO THE COAL DISPLAY AND RESTROOMS.

B. REVIEW & ACT TO ACCEPT THE FISCAL 2018/2019 AUDIT FINDINGS FROM RALPH OSBORN CPA.

Ralph Osborn states on page 5 balance sheet for the Town the total in cash \$1,104,053. On Page 6 is the Income and expenses, Ralph states that we had \$1,974,623 in revenue. Sales tax was up about \$50,000 over the year. Fines were up about \$20,000. The total expenses being \$1,789,851. Transferring \$184,772.00. The net change was \$130,000. He stated that we have increased the balance \$973,000 to \$1,104,000. Ralph states that there are no findings in the Audit. Ralph asks if there are any questions. Tommy Walker asks about the Marijuana taxes. Ralph states that that would come from the tax commission. Mayor Watkins asks for a motion to approve the audit findings.
