Mr. Kern states that our operating expenses was \$240,460.99. Mr. Kern states that in the past for repair and maintenance we are averaging \$35,000 a month, and we have spent \$75,000 in two months. Mr. Kern states that since we transferred the \$75,000 it put the PWA in the positive. Mr. Kern states that we still are paying the city back. Mr. Kern states that we will do the rate increase in December. Mr. Kern asks if there are any questions.
