Mr. Kern states that we will still do the increase for the water. Tommy Walker states that we have \$81,000 in the Water Tower Account, and asked if we can put that in a CD. Mr. Kern states that we can talk about that at the next meeting. Chairman Watkins asks if there are any questions.
