Total Expenses for October were \$148,918.07 so we spent \$13,857.00 more than we took in. Year to date for 4 months we have spent \$46,217.37 more than we took in and as in normal years, we have spent most of our capital money in the first part of the year. It's the same scenario that we usually experience so now we should start seeing revenues in excess of expenses because we have most of our capital purchases taken care of. I don't see any other issues. On the Street Department, the very first line item Asphalt Street Dept ST that is old monies collected years past and we had to spend that money on street and alley. As you can see we spent \$8,000 more than was in that account so on the next agenda I will have to approve the Street and Alley to pay back that \$8,311.41 to the General Fund because the General Fund shouldn't have had to pay for that.
