## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KREBS, OKLAHOMA:

Persons who are cited for violation of one of the traffic regulatory ordinances of this city, or driver's license offense, or a violation involving intoxicating drugs or beverages, may elect to pay a fine in the Traffic Violations Bureau according to the following schedule:

1. School zone violations - $\$ 98.00$
2. Traffic Violations resulting in personal injury or property damage $-\$ 251.00$
3. All traffic violations resulting in an accident with one or more vehicles- $\$ 146.00$
4. Passing a school Bus loading or unloading $-\$ 98.00$
