RESOLUTION 23-01

A RESOLUTION AUTHORIZING THE CALLING AND HOLDING OF A GENERAL ELECTION IN THE CITY OF KREBS, COUNTY OF PITTSBURG, STATE OF OKLAHOMA, ON APRIL 4TH, 2023, FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED ELECTORS OF THE CITY OF KREBS, OKLAHOMA, THE QUESTION OF THEIR APPROVAL OR REJECTION OF ORDINANCE 23-02 EXTENSION OF THE EXISTING ONE PERCENT (1%) KREBS SALES TAX.

WHEREAS, the City Council of the City of Krebs, Oklahoma, heretofore on the 20th day of January 2023, enacted Ordinance No. 23-02 which relates to the levy of a one percent (1%) sales tax on the gross receipts of sales for the purpose of: Completing and Maintaining streets, drainage, and other capital improvements and

WHEREAS, under the provision of Oklahoma law, such an Ordinance must be submitted to and approved by a majority of the registered voters of the City at any election called and held for such purpose before such Ordinance shall become effective;

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF KREBS, OKLAHOMA:

SECTION 1. The Mayor of the City of Krebs, Oklahoma, be and he is hereby authorized and directed to call an Election to be held in the City of Krebs, Oklahoma on Tuesday, the 4th of April, 2023, for the purpose of submitting to the qualified electors of the City of Krebs, Oklahoma, for their approval or rejection, the following proposition:

PROPOSITION NO. 1

Shall Ordinance No. 23-02 of the City of Krebs, Oklahoma, being an Ordinance amending the "Krebs Tax Ordinance", as amended, which will authorize the extension of the levy of a sales tax of one percent (1%) upon the gross proceeds or gross receipts derived from all sales taxable under the Sales Tax Law of Oklahoma; fixing effective date: making tax cumulative; providing that the proceeds of such sales tax shall be used for the purpose of: Completing and maintaining streets, drainage and other capital improvements on behalf of the City of Krebs Oklahoma. PROVIDED FURTHER, this sales tax shall be an extension of the existing one-percent sales tax and will end by operation of law on April 1, 2033.

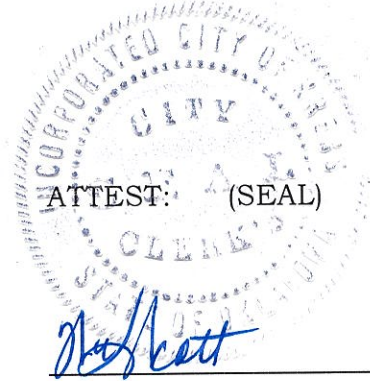

SECTION 2. That the call for such General election shall be by the Mayor and attested by the City clerk, setting forth the propositions to be voted upon, and the hours of opening and closing of the polls. The ballots for the qualified electors shall set forth the propositions substantially as set out in Section 1 hereof, and the returns of such election shall be made to and canvassed by the Pittsburg County Election board.
