## MINUTES OF THE CITY OF KREBS COUNCIL MEETING KREBS CITY HALL September 20, 2016 at 7:00 p.m.

- 1. Vice-Mayor Tommy Walker called the meeting to order.
- 2. Clerk/Treasurer W Kay Scott called the Roll. Bobby Watkins Absent, Tommy Walker Present, Connie Poole Present, Jason Wagnon Present, Daulfin Bennett Present.
- 3. Vice-Mayor Tommy Walker asked Ed Klink to lead the Prayer. Vice-Mayor Walker led the Pledge of Allegiance.
- 4. CONSIDER AND ACT TO APPROVE THE MINUTES OF THE AUGUST 16, 2016 CITY COUNCIL MEETING. Vice-Mayor Walker asked for a motion. Daulfin Bennett made the motion. Jason Wagnon seconded the motion. Vice-Mayor Walker asked Pat Layden, City Attorney is he was allowed to vote since he is Acting Mayor. Mr. Layden stated yes. Vice-Mayor Walker called for a vote. Daulfin Bennett yes, Jason Wagnon yes, Connie Poole yes, Tommy Walker yes. Motion passes.
- 5. CONSIDER AND ACT TO APPROVE THE CLAIMS. . Vice-Mayor Walker asked for a motion. Connie Poole made the motion. Daulfin Bennett seconded the motion. . Vice-Mayor Walker called for a vote. Daulfin Bennett yes, Jason Wagnon yes, Connie Poole yes, Tommy Walker yes. Motion passes.
- 6. REVIEW CITY OF KREBS FINANCIAL STATEMENT WITH MIKE KERN. Page 3 in the Financial Statement for the General Fund. The month of August Revenues were \$131,083.49 and total Expenses were \$126,546.69. Income was \$4,536.80 for the month of August. One item under the Street Dept Capital Outlay was for the oil distributor. That money can be transferred from the Street & Alley Fund. We budgeted it out of the Street & Alley fund. We are actually going to be ahead about \$20,000. Any questions from the council?
- 7. PUBLIC COMMENTS, QUESTIONS AND ANSWERS CONCERNING THE CITY OF KREBS BUSINESS. Paul Morgano addressed the council. He received an invoice for fire services from February and March for \$2,100. Questioned why so late. Mrs. Scott answered short-handed in the office and finally got all the bills sent out. Mr. Morgano stated according to the notes the subscription was suspended in 2014 and not approved until October 2015 to be reinstated. I was told by the firemen that you weren't taking subscriptions, that it got suspended. Mr. Walker asked Mr. Morgano if he paid every year? He said I pay every year. Chuck Nelms stated that when we did the Fire Recovery that the ordinance abolished all of the previous ordinances. When you rescinded the Fire Recovery, you never put the other ordinances back in place until later. Mr. Walker ask Mr. Klink if he remembered. Mr. Klink replied he remembered when the council rescinded the subscription but not the dates. The proper course of action since the information that was received was not clear that we should rescind this bill. Mr. Walker stated that since we didn't know what was going on.

Harvey Bynum addressed the council about a fire that he had and that had gotten away and he called in for Alderson Fire Dept. In Alderson Fire District and I got a bill from Krebs for \$750. Why am I getting a bill from Krebs when I called Alderson? Mr. Walker asked Chuck Nelms if we had an agreement with other fire departments if they need help, they call Krebs? Mr. Nelms stated yes. Mr. Bynum stated that Alderson should be the billing party instead of Krebs. Mr. Nelms stated that if they have a subscription and the person has paid the subscription through them, then the person is exempt from being billed by other agencies because you are doing a mutual aid to that department. If they don't have a subscription through their department then basically it is the same scenario. If they have a subscription and they haven't paid it through them then they are subject to a bill from their department then they are subject to a bill from any fire department. Since the mayor is out of town and we will see what we can do when he gets back. Mrs. Scott asked Mr. Bynum what his phone number – 918-302-8510.

Theresa McCurtain asked what can be done at the school on the highway. Can stop signs or stop lights be installed. It has become very dangerous. Mr. Walker stated she would have to go to the State Department. We tried that once before.

Dave Davidson \$600; Mike Jo Maisano \$651 or \$657 (illegible); Brent Imler \$151; Steve Dodd \$200; and Leon Bogard \$1,002 (Highest bid). Vice-Mayor Walker asked for a motion. Daulfin Bennett made the motion to accept Leon Bogard's bid. Jason Wagnon seconded the motion. Vice-Mayor Walker called for a vote.   - B. CONSIDER AND ACT TO ACCEPT THE WORKPLACE WELLNESS POLICY. THIS IS A PORTION OF THE TSET REQUIREMENTS TO OBTAIN GRANT MONIES. Michelle Mabray and Carlitta Lott with the Pittsburg County Health Department spoke to the council about the Healthy Living for employees and the community. Three main topics for Healthy Living are nutrition, physical activity, and tobacco-free. Vice-Mayor Walker asked for a motion. Connie Poole made the motion. Jason Wagnon seconded the motion. Vice-Mayor Walker called for a vote. Daulfin Bennett yes, Jason Wagnon yes, Connie Poole yes, Tommy Walker yes. Motion passes.
  - C. CONSIDER AND ACT TO ACCEPT THE MCALESTER WELLNESS CENTER'S SECOND OPTION WHICH IS THE CITY PAYS \$1,500 PER YEAR AND THE EMPLOYEES PAY \$15.00 PER MONTH FOR THE USE OF THEIR FACILITIES. THIS IS ANOTHER PORTION OF THE TSET REQUIREMENTS. Jonathan Taylor with the McAlester Wellness Center explained the fees and plan. The plan includes the employees full and part time, council members, fire department, attorney, judge, and accountant. Vice-Mayor Walker asked for a motion. Connie Poole made the motion. Jason Wagnon seconded the motion. Vice-Mayor Walker called for a vote. Daulfin Bennett yes, Jason Wagnon yes, Connie Poole yes, Tommy Walker yes. Motion passes.
  - D. CONSIDER AND ACT TO APPROVE ORDINANCE 16-05 WHICH IS A TOBACCO-FREE AND VAPOR-FREE ORDINANCE FOR LOCAL GOVERNMENT PROPERTY. THIS IS AMENDING ORDINANCES 07-02 PREVENTION OF YOUTH TOBACCO USE AND ORDINANCE 07-03 CLEAN INDOOR AIR ACT. Michelle Mabray and Carletta Lott explained the promotion of a smoke-free and vapor-free community. This will improve the health and wellness of the community and will go toward making Krebs a Certified Healthy City. This includes all tobacco and vapor products. Vapor products are not regulated by the FDA or USDA. Vice-Mayor Walker asked for a motion. Connie Poole made the motion. Daulfin Bennett seconded the motion. Vice-Mayor Walker called for a vote. Daulfin Bennett yes, Jason Wagnon yes, Connie Poole yes, Tommy Walker yes. Motion passes.
